H.R. 5140 - Economic Stimulus Bill of 2008 - Provides economic stimulus through recovery rebates to individuals, incentives for business investment, and an increase in conforming and FHA loan limits. This included tax rebate checks for individuals making less than \$75,000, and married couples making less than \$150,000.

- <u>Spending is not Stimulus!</u> "Any money that the government puts in the economy's *right pocket* is money that is first removed from the economy's *left pocket*". Cato Institute
- Reducing the size and scope of government = best way to improve economic performance.
- <u>Case Study</u>: Japan, throughout the 1990s tried to use so-called stimulus packages in an effort to jump-start a stagnant economy. But the only thing that went up was Japan's national debt (now approaching an astonishing 240% GDP at ~\$14 Trillion), which more than doubled during the decade, The Japanese economy never recovered, and the 1990s are now known as the "lost decade" in Japan.

The new drug benefit will account for almost 30 percent of this unfunded liability. As a result of the growth of entitlement programs and the aging of the population, the Government Accountability Office estimates that to balance the budget in 2040, the government would have to slash total spending by about 60 percent or raise taxes to 2.5 times today's level.
