POLITICAL COMMITTEE REGISTRATION FORM

The Campaign Reporting Act defines a political committee, in general, to mean two or more persons other than a candidate's campaign committee who are selected, appointed, chosen, associated, organized or operated <u>primarily</u> for a political purpose that is, to influence or attempt to influence an election. The term political committee includes political action committees and similar organizations composed of employees or members of any corporation, labor organization, trade or professional association or any other similar group that raises, collects, expends or contributes money or any other thing of value for a political purpose.

The law also requires that political committees register with the Secretary of State within ten days of receiving or spending more than \$500.00 in a calendar year. A onetime registration fee of \$50.00 is required. If the political committee does not receive or spend more than \$500.00 in a calendar year, then it is not required to register or file reports of contributions and expenditures.
