



Katie's Law is named after Katie Sepich, a 22-year old college student whose killer Susana prosecuted and convicted. The law now requires law enforcement to take DNA for most felony arrests and include the samples in a database to help bring criminals to justice.

FIGHTING CORRUPTION

When it comes to fighting corruption in government, Susana Martinez has a real record. Her office has prosecuted and convicted corrupt public officials, including convicting the Doña Ana County Clerk of five felony charges.
