To whom it may concern:

I have attached the Elections, Ethics, and Voter Complaint form as well as the Third Primary Campaign Finance Report of Mr. D'Antonio filed with the Secretary of State's office June 2, 12016 at 9:33 am. The fifth page of the financial report attached contains a loan contribution from Chiaki Miyazaki of 3555 Canyon Ridge Arc, Las Cruces, NM 8011 in the amount of \$7,137.00. As you well know, the contributions from an individual person to a candidate for non-statewide office increased to \$2,500.00 on November 5, 2014. This loan contribution violates the contribution limits and thus violates state law. According to 1-19-34.7 Contribution limitations; candidates; political committees, contained in the Campaign Practices law of the state, the limitations on contributions to a candidate does not apply to a candidate's own contributions from the candidate's personal funds to the candidate's own campaign. The loan in question is not from the candidate and could violate contribution limits. If a candidate is allowed to take third party loan contributions, they could simply use the funds and forgive the loan after the election to violate the cap on individual campaign contributions. I would ask the Secretary of State to launch an investigation into the loan contribution contained on this financial report to ensure that the loan does not violate state contribution limits.
